Contents Box 299T

Box 299T is a box of transcriptions and translations of the early court rolls, made around one hundred years ago. It is part of the archive but is currently (2024) held at Whitehaven Archive Centre.

The box is listed as one item in the CAS DLEC catalogue as DLEC/1/13/36

There are Latin transcriptions and English translations of the first 26 early General Court Rolls, covering: Honour of Cockermouth, Lordship of Derwentfells (with Braithwaite and Coledale), Lordship of Five Towns, Barony of Allerdale, Barony of Wigton, manors of Westward, Aspatria, Papcastle, Broughton, Loweswater, Brackenthwaite, Crosby, Whitehall, Birkby, Uldale, Caldbeck, Dean, and Whinfell.

Folder 27 contains a transcription and translation of parts of Receiver's accounts rolls 29 and 30 giving the accounts for the year ending Michaelmas 32 Eliz 1. Marked duplicate. The folder lists a number of such translations which are not contained.

The mapping between image folders and catalogue references is given below.
